1. Data collection

Data will be collected, where possible, using the Qualtrics online survey platform. Qualtrics was chosen as it is GDPR compliant, allowing the REFUGE-ED consortium to easily manage our obligations under GDPR, including the ability to manage Right to Erasure requests. Similarly, and as per advice from the Data Protection Officer, Trinity College Dublin, Qualtrics <u>settings</u> will be enabled to ensure that participants' IP addresses, as a form of personal data, will not be collected.

To create the database, each of the instruments/tools included in D4.1 Compendium of Tools was created separately in a shared REFUGE-ED library on Qualtrics (note, in Qualtrics terminology, each instrument is a 'project'), see screenshot below:

Links to each of the instruments on Qualtrics are included in D4.1, for viewing purposes. Where available, tools and questionnaires will be made available across the languages of the various pilot action sites. This Qualtrics library will therefore allow us to quickly and consistently develop the surveys to be used within each pilot





action, ensuring that data is collected in the same way, using the same measurements for the same indicators across pilot action sites.

Following the needs analysis, project partners will complete <u>a quick survey</u> for each of their pilot sites. The results of this survey will inform the WP4 team of which instrument(s) were co-selected together with relevant stakeholders to form part of the outcome evaluation at each site. The WP4 team will then assist each pilot site to construct their base-line (and end-line) evaluation tools by compiling these from the instruments in the shared REFUGE-ED library on Qualtrics.

Given the varying resources available at each pilot site, and while the preferred means of data collection remains electronically, it is possible that some data may be collected in pen-and-paper format. In this case, REFUGE-ED staff will scan the paper versions and save these files on OneDrive for record-keeping. The paper version of the documents will be securely shredded. REFUGE-ED staff (with support from the WP4 team, where necessary) will then enter the data into Qualtrics.

2. Data storage




FIGURE 2 EXAMPLE OF DATA EXPORT OPTIONS FROM QUALTRICS

All data collected at each pilot site will be exported from Qualtrics by the WP4 team, see screenshot in Figure 2 below:

In line with D4.2 Guide to the SPICE cycle, data will be collected across multiple timepoints at each pilot action site, as part of the outcome evaluation. In order to do this, a unique participant identifier will be created for each participant, which will be linked with the data they provide at each timepoint, allowing each pilot action site, together with support from the WP4 team, to match their responses over time (i.e., a dependent sample design) and identify any differences that may be associated with participation in the practice implemented within and across each pilot action site. Consequently, this will facilitate conducting cross-country and cross-site analyses.

As outlined in D7.1, cleaned (and where necessary, anonymised/pseudonymised) data will be later uploaded to Zenodo open data repository, in accordance with Open Science principles.
